

More than 100 supervisory committee members, directors and internal auditors from across the country gathered in historic Savannah, Georgia to take part in NACUSAC's 2013 Annual Conference. The three and a half day agenda featured an expert lineup of speakers and a multitude of sessions geared toward helping supervisory committees fulfill their oversight role.

Madoff Whistleblower Headlines Program

In his keynote entitled "Why Ethics and Transparency Are Critical!" whistleblower Frank Casey captivated the group by recounting the story of how he and Harry Markopoulos uncovered Bernie Madoff's elaborate Ponzi scheme. In the process of exposing Madoff, Casey learned that transparency is absolutely essential in preventing financial fraud. Madoff promised a return on investment that just wasn't possible given the fluctuations in the market. As Casey pointed out, "It goes back to the saying, if something is seems too good to be true, then it probably is."

Matz Details Examination Hot-Buttons

NCUA Chairman Debbie Matz outlined the areas where examiners will be focusing, including interest rate risk, third-party risks, cyber security threats and off-balance sheet risks. She also highlighted NCUA's plan to help ease some of the regulatory burden that credit unions have had to manage.
