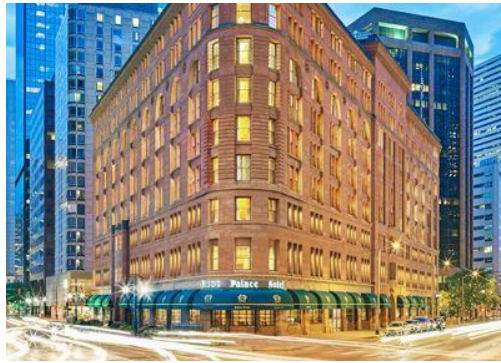
### Sign up for NACUSAC's 2020 Annual Meeting
